TERMS AND CONDITIONS

- 1. The deposit is required to secure the time slot.
- 2. All outstanding amounts to be paid at the end of the event.
- 3. All parties/events are to be held within the operating hours of 9am - 5pm. Charges apply outside regular hours.
- 4. The school & its representatives are to adhere to the booked timing. Should the visit exceed the agreed time slot, the school shall be charged accordingly.
- 5. The school & its representatives shall be responsible for the supervision of their students. They shall ensure the health and safety of everyone present at all times and shall release Kaboodle and all its governing boards, staff, and volunteers from any liability in the event of illness or injury to the child, and/or loss or damage to their property.
- The Customer and their guests are to not use the facilities and/or equipment for any purposes other than what they 6. are intended for.
- 7. All shoes must be removed before entering Kaboodle and socks are mandatory for both children and adults in the block play area. Non-slip socks recommended
- 8. STRICTLY no food and drinks in the block play area.
- 9. No jewellery, badges, or sharp objects shall be brought into the play area.
- 10. Kaboodle reserves the right to cancel or postpone any bookings due to unforeseen circumstances.
- 11. Postponement of event by school in under 7 days due to unforeseen circumstances
 - a) Kaboodle postponement fees 50% of deposit **OR** full deposit if under \$100
- 12. For cancellation, an advanced notice of minimum 21 calendar days from the date of event is required. Cancellation charges apply:
 - a) Cancellation made before 21 days from the date of the event, cancellation charge will be at 50% of the deposit paid.
 - b) Cancellation made within 21 days from the date of the event, cancellation charge is at 100% of the deposit paid
